Dear Chancellor Davis:

Our Mandatory Student Fee Advisory Committee has made its recommendations to me on Georgia Tech's mandatory fees for Fiscal 2012. I am submitting these same recommendations to you, as summarized in the attached form. The increases requested total \$12 per semester, a \$4 request each for the Transportation, Student Health, and Athletics fees.

Georgia Tech's Mandatory Student Fee Advisory Committee is comprised of eight students plus two faculty and two staff. This year the student members include the presidents of the graduate and undergraduate SGAs, three SGA vice presidents, and the SGA chief of staff. For your information, the Committee maintains a web site to post fee request and other backup documents for their work, which includes the policy stating the Committee's composition and ground rules (<http://www.budgets.gatech.edu/MSFAC/>). As noted in the documents on this web site and those submitted to your staff, these are all critical increases required to maintain existing service levels to students.

Please let me know if you would like further information regarding these requests. Georgia Tech's Office of Budget Planning and Administration has submitted the necessary backup documents to the USG Budget Office.
