1. Attendance – All committee members were present or represented. Additional staff members were present per the attendance list on the last page.
2. Review of Meeting Summary – November 15, 2013 – The Committee reviewed the Meeting Summary from the November 15, 2013, and it was approved by unanimous consent.
3. Presentation of Mandatory Fee Requests for FY2015
  - Athletics – Michael Bobinski and Frank Hardymon updated the committee on the status of Athletics Fee. It was determined at this time that there would not be a request for an increase. The fee for athletic remains at \$127 for Fall and Spring semesters and a summer fee of \$40.
  - Student Health Fee – John Scuderi updated the committee on the status of the Health Services Fee. It was determined at this time that there would not be a request for an increase. The fee for health remains at \$160 for Fall and Spring semesters and a summer fee of \$107 .
  - Transportation – Lance Lunsway updated the committee on the status of the Transportation Fee. It was determined at this time that there would not be a request for an increase. The fee for transportation remains at \$81for Fall and Spring semesters and a summer fee of \$54.
  - Student Activity – There was not a request for a fee increase for the Student Activity Fee for FY2015.
  - Technology Fee – Lawrence Bottomely updated the committee on the status of Technology Fee and the need to consider going forward a potential increase in the near future. It was determined at this time that there would not be a request for an increase. The fee for technology remains at \$107 for Fall and Spring semesters and a summer fee of \$107.
