## <u>Meeting Summary</u> Mandatory Student Fee Advisory Committee Friday, December 05, 2012 Crescent Room, Student Center Commons, 3:00 P.M. to 5:00 P.M.

- 1. <u>Attendance</u> All committee members were present. Additional staff members were present per the attendance list on the last page.
- 2. <u>Review of Meeting Summary November 13, 2012</u> The Committee reviewed the Meeting Summary from the November 13, 2012, and it was approved by unanimous consent.
- 3. Presentation of Mandatory Fee Requests for FY2014
  - <u>Transportation</u> Lance Lunsway and David Williamson updated the committee on the status of the Transportation Fee. It was determined at this time that there would not be a request for an increase. The fee for transportation remains at \$81 for Fall and Spring semesters and a summer fee of \$54.
  - <u>Student Health Fee</u> Gregg Moore presented the Health Services fee proposal for a \$6 increase, from \$154 to \$160 for Fall and Spring semesters with a summer fee of \$107. He informed the Committee that additional funds are needed to cover staffing and operating expenses related to opening a new medical clinic and increased hours in Psychiatry. This will allow for increased availability of appointments to meet the growing needs of the student population. Funds are needed also to cover the increased cost from suppliers for services, supplies and technical support.
  - <u>Athletics</u> Frank Hardymon presented a proposed increase in the Athletics fee of \$6 from \$127 to \$133 (no change to summer fee of \$40). This increase will help Georgia Tech move closer to the conference average fee. In addition a fee increase would help to avert a budgetary shortfall resulting from maintenance and upkeep of Bobby Dodd Stadium as well as ticket and premium seating revenue challenges.
  - <u>Student Activity</u> There was not a request for a fee increase for the Student Activity Fee for FY2014.
  - <u>Technology Fee</u> There was not a request for a Technology Fee increase for FY2014.
  - Jim Kirk suggested that the Committee consider methods of informing the students of the status
    of mandatory fee requests. Students should be informed and have a means of expressing their
    opinions regarding the fees. Currently most information regarding the fees is communicated via
    <u>The Technique</u>. Daniel Farmer volunteered to be a resource for the Committee in determining
    how this could be accomplished.
